The 2018 Annual Stockholders Meeting of Stemline Therapeutics, Inc. will be held on Thursday, June 21, 2018, at the offices of our legal counsel, Alston & Bird LLP, located at 90 Park Avenue (between 39th and 40th streets), New York, New York 10016, at 10:00 a.m. ET.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** all nominees, **FOR** Proposal 2 and 3:

1. Election of two Class III directors, two Class II directors, and one Class I director, each to serve until their successors are duly elected and qualified
2. Ratify the appointment of Ernst & Young LLP as our independent registered public accounting firm for the year ending December 31, 2018
3. Approval of an amendment to our 2016 Equity Incentive Plan to increase the number of authorized shares issuable thereunder by 2,900,000 shares
