**Explanation of Responses:**

The reporting person had no discretion with respect to such sale, which was conducted automatically in accordance with the issuer's corporate policies. 4,319 shares were sold on December 23, 2019; 24,477 shares were sold on December 24, 2019; 15,494 shares were sold on December 26, 2019; and 2,022 shares were sold on December 27, 2019.
